Accidental 9-1-1 Calls in 2020:

NTECC processed 6,648 abandoned calls (or 9-1-1 hang-ups) which, on average, take over 3 minutes each to resolve. That's almost 356 hours. If you accidently call 9-1-1, don't hang up. Tell the dispatcher it was a misdial and that you do not have an emergency. If you hang up, the dispatcher will try to call back and may dispatch an officer if it cannot be determined that an emergency exists; thereby, depleting emergency resources unnecessarily. Remember, stay on the line so dispatchers can quickly be ready for the next call, which may be a life-or-death situation.

What exciting and interesting Texas Special Legislative Sessions we have had! As most of you know, enough Texas Democrat Representatives broke quorum, by leaving Texas, that the House was prevented from conducting business during the first Special Session. Enough returned during the Second Special Session allowing the House to move forward. This article was due August 25, so I cannot tell you the outcome of the Second Special Session, but I have provided links below so that you can view the status of bills pertinent to Texas retired school personnel. I am also including a review of legislation passed in the 87th Legislative General Session.

Update: SB 7 passed the House on August 27th!! (editor's note)

In other news:

U.S. Representative Beth Van Duyne (TX-24) has not signed on as a co-sponsor for HR 2337 – Windfall Elimination Provision reform which TRTA has worked for several years to bring about. Please call her office at **202.225.6605**, and ask that she support Texas retired school personnel by signing as a co-sponsor for HR 2337. WEP unfairly reduces <u>earned</u> Social Security payments for public school personnel as well as police and firemen.

TX Representative Michelle Beckley (HD 65) and Derrik Gay (Carrollton tax attorney) have filed to run against U.S. Representative Beth Van Duyne in 2022.

TX Senator Jane Nelson (SD 12) has announced her retirement.

TX Representative Tan Parker (HD 63) has filed to run for SD 12.

87(2) HB 5

Relating to making supplemental appropriations and giving direction regarding appropriations of \$701 million in General Revenue.

87th Legislative Session Review

Senate Bill 1 - The Finance Bill

• SB 12 passed in 2019 to increase contributions to TRS until they reach 8.5% in 2025. SB 1 is a commitment to increase funding in the 2023 session to keep the fund sound.

House Bill 1585 - The Sunset Bill

• Created a position at TRS to be more responsive to members needs and to assist them with agency issues.

- Requires TRS to publicly report financial bonuses made to its investment managers.
- Increases customer service in health care appeals.
- Changes the exemption date for full-time work restrictions and penalties to allow any current retiree who retired prior to January 1, 2021 to return to work full time with no penalties or restrictions.

HB 2022- Golden Ticket Bill

• The golden ticket bill will allow Medicare age-eligible retirees who left TRS-Care between 2017 and 2019 a one-time opportunity to rejoin. If Governor Abbott does not veto the bill, it becomes law on September 1, 2023. Please speak with a TRS counselor before making any decisions related to health care insurance.

SB 288 - Return-to-Work Bill

- Retirees who returned to work in the classroom faced losing an entire monthly pension check as a penalty for working over their allotted time period by even a small amount, defined as half-time by TRS.
- SB 288 reforms the penalty structure to require warnings before any financial penalties are incurred.
- TRS members who retired before January 1, 2021, are exempt from all work limits.

HB 3207 - Return-to-Work Disaster Bill

• HB 3207 provides a path for retirees to return to work with no penalties or surcharges during times of a declared disaster, such as during and after the February 2021 winter storm.

SB 1356 - The Tutoring Bill

• SB 1356 allows organizations, such as the Texas Retired Teachers Foundation and TRTA, to offer tutoring services to school districts. A retired educator working as a tutor who is paid with federal funds will not have any TRS-related return-to-work issues, nor will the school district surcharge apply to their service.

SB 202 - TRS Contributions

• SB 202 changes the current practice allowing TRS surcharges to be shared by the employer (the school district) and the employee (the TRS retiree). The employer (the school district) is now responsible for all surcharges for the pension fund and TRS-Care for employees who have returned to work more than half-time.

SCR 17 - WEP Reform

• SCR 17 is a request from the Texas Legislature to the federal government to repeal and reform the harmful Windfall Elimination Provision (WEP).

COLA: Texas Senate Passes 13th Check Bill

• SB 7, by Sen. Joan Huffman (R – Houston), passed unanimously through the Texas Senate and would provide a supplemental payment to retired educators equal to the lesser of a retiree's current monthly annuity or \$2400. It is in the House (Special Session 2)

There is no limit to the number of tutoring hours a retiree may work per month. All retirees who retired before January 1, 2021, are exempt from all penalties to their annuity if they return to work.

Healthy Living

September is **National Cholesterol Education Month**. It's a great time to learn ways to keep our blood cholesterol levels within normal ranges. Please check with your doctor for your current levels and take steps to lower your cholesterol levels when necessary.

Living a healthy lifestyle can help keep our cholesterol in a healthy range and lower our risk of heart disease and stroke. But, unfortunately, everyone's risk for high cholesterol goes up with age. As we age, our bodies don't clear cholesterol from the blood as well as they did when we were younger, leading to higher cholesterol levels which affect our **heart health**.

Our body makes all of the cholesterol it needs, so we do not need to obtain cholesterol through foods. However, eating large amounts of foods high in saturated and trans-fat may contribute to high cholesterol. Below are ways to **practice** good heart health:

- Limit foods high in saturated fat, such as cheese, fatty meats, and dairy desserts.
- Choose foods low in saturated fat, trans fat, sodium (salt), and added sugars; examples include lean meats; seafood; fat-free or low-fat milk, low-fat cheese and yogurt; whole grains; and fruits and vegetables.
- Eat foods naturally high in fiber, such as oatmeal and beans (black, pinto, kidney, lima), and unsaturated fats, which can be found in avocado, vegetable oils like olive oil, and nuts.
- Get 3 hours of moderate-intensity exercise every week, such as brisk walking or bicycling.

As you embrace our tagline, "Healthy Living is a Lifestyle," remember that each day is a fresh start! Stay focused, develop a positive attitude, and remain passionate with your goals
