#### Voters approve our COLA

We did it! Our COLA will begin in January 2024. We certainly did our part. C-FB RSPA distributed 140 yard signs, 90 buttons, nearly 3,000 push cards, and educated voters in countless encounters, emails, and on social media. We informed through candidate forums and I recruited one candidate to distribute push cards in campaign materials. THANK YOU, RSPA members!

Another benefit, Prop 9 received 23,827 more votes than Prop 4 which will give us leverage in future legislative sessions to obtain future COLAS. I

hope you took the opportunity to thank your legislators through Tim's November 7 Inside Line Action Alert. If you have not done so, call or email your senator and representative and thank them for their support.

### Time to focus on WEP

On the Federal level, the Windfall Elimination Provision and Government Pension Offset are currently being addressed in H.R.82 Social Security Fairness Act of 2023 which repeals provisions that reduce Social Security benefits for individuals who receive other benefits, such as a pension from a state or local government. This bill eliminates the government offset pension, which in various instances reduces Social Security benefits for spouses, widows, and widowers who also receive government pensions of their own. This bill also eliminates the windfall elimination provision, which in some instances reduces Social Security benefits for individuals who also receive a pension or disability benefit from an employer that did not withhold Social Security taxes.

In 2022, the Speaker of the House did not allow this bill to reach the floor of Congress. Please contact your representative in Congress and encourage him/her to support and vote for H.R.82 should it reach the floor of the House during this session. For many of you, that would be Rep. Beth VanDuyne (TX-24) 972-966-5500, 202-225-6605. Encourage her to become a co-sponsor. There are 305 of the 435 Representatives who have signed on as co-sponsors. Rep. VanDuyn is not listed a co-sponsor.

Thank you, again, for your enthusiasm and effort in getting out the vote for Prop 9!

Record volunteer hours regularly. A datebook or calendar is useful.
