Program: 'Tis the Season for Weather Preparedness, Are you Ready?

Are you weather prepared? Do you know what that even means?

Come hear from Dan Henry who is an Emmy award-winning meteorologist with 35 years of broadcast television experience. Dan currently works at FOX 4 in Dallas, where he has served as the station's Chief Meteorologist since 2003.

Dan attended Penn State University where he earned a B.S. in Meteorology. While at Penn State, he completed a three-semester internship at the National Weather Service's Techniques Development Lab in Washington, D.C. that landed him a job as a research meteorologist upon graduation. After two years of number crunching, Dan was ready to chase his dream of becoming a TV meteorologist. He landed his first on-air job at WECT in Wilmington, NC in 1990 and never looked back.

It was shortly after the 2015 December 26th tornado outbreak that Dan set out to write a book to help educate people about the importance of severe weather preparedness. Over the next two years, he tracked down several Texas storm survivors and interviewed them. Their harrowing stories, combined with an explanation of the science that caused the deadly events they survived, are collected in his recently published book, "Menacing Skies: Texas Weather and Stories of Survival."

Dan has been awarded five Emmys, including three for best television weathercaster in Texas. He earned the American Meteorological Society's Seal of Approval in 1992, and was the first meteorologist in the Dallas-Fort Worth area to earn the prestigious Certified Broadcast Meteorologist Seal in 2007.

Dan continues to volunteer his time for charitable fundraisers and speaking engagements on such topics as severe weather preparedness and climate change. In his spare time, he enjoys working out in the yard and in the gym, exploring the outdoors, and admiring beautiful Texas sunsets. Don't miss the great information Dan will be sharing with us as we advance into our winter season.

## **Legislative Chair - Pat Enlow**

HR 82 (repeal of WEP and GPO) passed the House 327 to 75 on November 12! It is now up to the U.S. Senate. Repeal of WEP and GPO is still a possibility, but your help is needed! If you have not called Senate Majority Leader, Chuck Schumer, please use the information below.

#### Here's How You Can Help! Contacting Sen. Majority Leader Schumer

Call **(202) 224-6542** and ask to speak to the staff member who works on Social Security issues. Here is a short script you may use:

- Hello, I am a member of the Texas Retired Teachers Association (TRTA). I am asking Sen. Majority Leader Schumer to please add <u>repeal</u> of the WEP and GPO to the Senate agenda now that H.R. 82 has passed the House of Representatives, before the end of this cycle.
- As a sponsor of repeal, and as a person who has direct influence over whether or not the **repeal** of WEP and GPO will win this Congress, we NEED Leader Schumer to bring this bill forward for a vote!
- Thank you for your support!

Do not forget to call our Texas Senators! Ask them to support <u>repeal</u> of WEP and GPO.Senator John Cornyn202-224-2934 and 512-469-6034Senator Ted Cruz202-224-5922 and 512-916-5834

Tell them your story – or mine: I paid into Social Security, but can only collect 35% of my **earned** Social Security because of the Windfall Elimination Provision. I cannot collect my spouse's **earned** Social Security if he should pre-decease me because of the Government Pension Offset.

I have talked to friends in Ohio, Missouri, California, and Colorado. They all have similar campaigns underway. We are not alone – 15 states are affected by WEP and GPO. Please ask anyone you know to help support us by also making these calls to Leader Schumer and their state Senators.

Holiday Greetings to all! December is filled with a flurry of activities and deadlines to meet. Here are the reminders of deadlines with our health insurance with the TRS Medicare Advantage Plan with United Healthcare.

- December 7 the final day to choose an optional dental and vision coverage. You have two options: one with TRTA or one with TRS. You should have received information by email or regular mail for both of these options.
- December 7 also the final day to re-enroll yourself or your spouse in the TRS Medicare Advantage Plan with United Healthcare if either of you left the plan or were using another health plan.
- December 31 the final day to use your credits totaling \$160 for the 2024 year of "Over the Counter" medical products. Use it or lose it!

December 31 – the final day to submit Rewardable Activities to United Healthcare so the dollar rewards can be loaded onto a Visa Card when the following activities are completed: Breast cancer screening \$25, Annual Physical or Wellness Visit \$25, Colon Cancer screening with a provider or at home - the \$ amount varies, Osteoporosis screening \$50, sign-up for Paperless Delivery of EOB's \$5, sign-up for Text Messaging with UHC \$5, Complete your HouseCalls Visit \$15. You may call UHC Customer Service (866-347-9507) to report your activities. Rewards are added to the Visa card.
