## **Legislative Report**

#### **Good News!**

# The 86<sup>th</sup> Legislature has come to a close with some good news for retired school personnel:

HB 500 appropriated \$1.113 billion from the Rainy Day Fund and SB 12 (passed on the very last day of voting):

- ⇒ Provides a supplemental  $(13^{th})$  check to all who retired by August 31, 2018, in the amount of your monthly annuity, not to exceed \$2000. I have not seen a specific date, but TRS has indicated it will be delivered in the fall.
- ⇒ Makes our TRS Fund actuarially sound paving the way for a Cost of Living Adjustment (COLA) to be considered by the  $87^{\text{th}}$  Legislature.

There will be no increases in our TRS-Care premiums.

YOU were a part of this outcome. It DOES help when each of us participates in the Action Alerts, contacts/ visits our legislators, and holds our legislators accountable with questions and clarifications. WE DID RAISE THE BASE!

### Windfall Elimination Provision (WEP)

On a national level, Tim Lee has been working with a Massachusetts retired public employees group to repeal the unfair Windfall Elimination Provision (WEP) which affects school personnel in 14 states.

In Texas, 95% of public school employees do not pay into Social Security through their public school jobs, but many supplement their income with jobs in which they do contribute to Social Security. WEP eliminates the "windfall" of those who receive both a pension and Social Security by reducing Social Security benefits!

U.S. Representative Richard Neal (D-Mass.) plans to introduce his WEP bill this summer. (Our own U.S. Congressman Kenny Marchant is up for re-election!)


are even more important than the **General Election (November 3, 2020),** because the Primary determines our choices!

## Our 2019-2020 Goals

The following are the goals we have set for 2019-2020 and our plans for implementing them.

- **Growth-** We attended our school district Retiree Dinner in May and recorded personal contact information so that we can invite retirees to our September meeting. We are planning an ice cream social in a CFBISD facility on August 27th for new retirees and our C-FB RSPA Executive Board. We want to inform new retirees about the process of joining RSPA, such as price, share about local dues and give information about what we do such as tentative list of program topics and field trips. We requested an open records list of all C-FBISD retirees for the past few months and have contacted them at their school district email addresses requesting their personal contact information. We put note cards on our lunch tables at our May meeting and asked members to give us the names and contact information for their friends and acquaintances who were retiring. (This turned out surprisingly well, and we got a good list of new prospects for our organization!) We will attend the CFBISD Professional Development Seminar for three days in August to recruit and connect with active educators. In February, we will recruit new members at our annual Retirement Seminar. We have added a new position, Publicity Chairperson, on our Executive Board this summer.
- **Political Awareness** We will contact our members and ask them to respond to each "Call to Action" issued by the State and District 10 Legislative Chairs and through Tim Lee's INSIDE LINE.. We will have at least one program each year that is designed to inform our members about Legislative issues. Our 2nd VP, Pat Enlow, or our Legislative Co-Chair, Nichie Hoskins, will give Legislative updates at each meeting and in each of our seven newsletters. We are planning to hold our second Candidates' Forum at our February C-FB RSPA meeting. We will visit Legislators and invite members to visit and/or contact legislators with questions or for clarification of issues.
- **Membership Engagement**-We have made an effort to involve new retirees in the leadership of our organization Two of our new officers are recent retirees and new members of C-FB RSPA Executive Board, and we have recruited new members to participate on our committees. We used a "Member Survey" to ask members of which committee they wish to be a part, and use that information to recruit for committees. Our Program Chair and our Field Trip Chairs use the information from our member survey to plan high interest, stimulating programs and field trips. Our Newsletters (7) are posted online and are "works of art"! They are always informative and upbeat. We serve great food at our luncheons!
